

The purpose of this modification is to: 1) Correct the obligated amount and total estimated price of the contract indicated in Modification No. 5; 2) Put into effect the changes to the contract as set forth in Attachment No. 1 (Banquet Event Orders #10536 - 10570 for the NRC's 2007 Regulatory Information Conference on March 13, 2007 through March 15, 2007); 3) Increase the total estimated price for Option Year Two of the contract by \$67,000.00, from \$263,452.60 to \$330,452.60, based on an estimate of the services to be provided by the contractor; and 4) Increase the obligated amount and total estimated price of the contract, including all options, by \$67,000.00, from \$742,623.40 to \$809,623.40. Accordingly, the contract is hereby modified:

1. Section B.3.1 CONSIDERATION AND OBLIGATION, paragraphs (a) and (b), as indicated in Modification No. 5 is corrected to read as follows:

- (a) The total estimated price of this contract for the products/services ordered, delivered, and accepted under the contract is \$742,623.40.
- (b) The amount presently obligated with respect to this contract is \$742,623.40."

2. As a result of this modification, Section B.3.1 CONSIDERATION AND OBLIGATION, paragraphs (a) and (b), as modified in Modification No. 5, is deleted and substituted with the following as follows:

- (a) The total estimated price of this contract for the products/services ordered, delivered, and accepted under the contract is \$809,623.40.
- (b) The amount presently obligated with respect to this contract is \$809,623.40."

NOTE: Of the \$67,000.00 obligated, an amount not to exceed \$5,000, is set-aside for orders issued by the Office of Nuclear Reactor Regulation's (NRR) representative (Sally Adams) to order unexpected miscellaneous items (e.g. audio-visual equipment, equipment rental, business center usage, etc.) necessary for the 2007 RIC, during March 13, 2007 through March 15, 2007.

3. Bethesda North Marriott Hotel and Conference Center is hereby directed to make the changes as set forth in Attachment No. 1 (Banquet Event Orders #10536 - 10570), in accordance with the Changes Clause of the contract, with the following exception: "The Federal Government is exempt from the 5% sales tax."

Bethesda North Marriott Hotel and Conference Center is hereby requested to provide a proposal for an equitable adjustment within 10 calendar days of the effective date of this change order. Upon completion of negotiations, a supplemental agreement (modification) will be issued by the Contracting Officer, to incorporate an equitable adjustment for this change order, if necessary.

The following is a summary of obligations, from the date of award through the date of this action:

FY 2005 OBLIGATIONS:	\$362,123.40
FY 2006 OBLIGATIONS:	\$238,500.00
FY 2007 OBLIGATIONS:	\$209,000.00
TOTAL NRC OBLIGATIONS:	\$809,623.40

This modification obligates fiscal year funding in the amount of \$67,000.00.

All other terms and conditions of the contract remain unchanged and in full force and effect.
