

The purpose of this modification is to:

- (1) Provide incremental funding in the amount of \$1,795,000.00, thereby increasing the obligated amount of the subject order from \$3,694,065.10 to \$5,489,065.10;
- (2) Exercise Optional Task 14 – Document Backlog Processing for Year Two of the Base Period;
- (3) Designate Mr. William M. Luch as the Technical Monitor for Task 18 – Nuclear Security and Incident Response (NSIR) ADAMS Document Processing Support Services.

Accordingly, the subject order is hereby modified as follows:

1. Optional Form 347, under Item 17 schedule, third paragraph, first sentence, is DELETED entirely and REPLACED with the following:
