This letter and the enclosed NRC Form 591M refer to the safety inspection conducted March 7, 2007, at a temporary jobsite located at the oil refinery facilities of CHS, Inc., Laurel, Montana. The results of the increased controls inspection will be communicated in a separate letter. This inspection was an examination of activities conducted under the General License provisions contained in 10 CFR 150.20 as they relate to safety and compliance with Commission's rules and regulations and with conditions of the license. At the conclusion of the inspection, a preliminary exit briefing was conducted with your assistant radiation safety officer to discuss the inspection findings. A final exit briefing was conducted telephonically with you on March 14, 2007.

Within the scope of this inspection, no violations were identified; therefore, no response to this letter or the enclosed NRC Form 591M is required.
