This firm has been retained to represent Petitioners in the referenced appeal. I shortly will be entering an appearance with the Court.

I understand that the telephonic pre-argument conference that had been scheduled for Monday, February 26, 2007 has been deferred. I further understand that the conference has been deferred to permit the referenced appeal to be consolidated with *NJ Env Fed'n vs. US Nuclear Reg Comm*, U.S. Court of Appeals for the Third Circuit, Docket No. 07-1304.

By Agency Appeal Scheduling Order No. 1, the Court set forth a schedule for the case.
