This letter is to inform you of executive management and organizational changes at the Gulf Coast Seafood Laboratory (GCSL), U.S. Food and Drug Administration, Dauphin Island, AL.

Effective February 28, 2007, Dr. Roland M. McPhearson, Director of GCSL, retired from government service. As Dr. McPhearson's replacement, Dr. Robert Dickey serves as the executive management representative responsible for the oversight of the facility's radiation safety program and, as such, a member of the GCSL Radiation Safety Committee. Dr. Dickey has appointed CDR Kevin Calci, an Environmental Health Officer of the Commissioned Corps, to serve as Chairperson of the Radiation Safety Committee (see attached). In this position, CDR Calci replaces Dr. Carol Shieh, who is transferring to another facility. While not a unit supervisor, CDR Calci received basic radiation safety training in 1998, is knowledgeable in radiation safety issues from completion of refresher radiation safety training annually, and demonstrates good leadership ability and credibility by virtue of his assigned position at the GCSL.

Dr. William Burkhardt, Facility Safety Officer, will continue to serve as a member of the Committee. And I will continue to serve as the GCSL Radiation Protection Officer, a position I have held since 1990.
