- 1. Table 3.6.2-1 note "B" will be changed to "A".
- 2. The Attribute/Exception table on page 4 of 6 will be deleted as it no longer applies (A24 stated this, but the table was left in).
- 3. Commitment 43 will be changed to remove options 1 and 3 and clarify when testing will be done as follows:

"Establish and implement a program that will require testing of the two 13.8 kV cables from the two Vernon Hydro Station 13.8 kV switchgear buses to the 13.8 kV / 69 kV step up transformers before the period of extended operation and within 10 year periods after the initial test."

4. Commitments 40 and 41 will be deleted as they are already contained within VY's CLB and existing programs.
