Office of Nuclear Reactor Regulation (NRR) Items of Interest Week Ending March 30, 2007

Containment Coatings Testing at McGuire

From March 20-22, 2007, the staff witnessed adhesion testing of containment coatings that was being conducted at McGuire Unit 1. The testing was conducted by Duke Power personnel and consultants under the auspices of Electric Power Research Institute/Nuclear Utility Coating Council (NUCC). Containment coating testing is being conducted at several plants in 2006/2007 to demonstrate that aged protective coatings maintain adequate adhesion. McGuire is the third unit to perform the testing. The results from the McGuire testing and that at other plants will be used to evaluate licensee supplemental responses to Generic Letter 2004-02, "Potential Impact of Debris Blockage on Emergency Recirculation during Design Basis Accidents at Pressurized-Water Reactors," and in resolution of Generic Safety Issue (GSI)-191, "Assessment of Debris Accumulation on PWR Sump Performance."

Quad Cities and Dresden - Management Meeting Regarding Extended Power Uprate Issues

On March 22, 2007, a Category 1 public meeting was held between representatives of NRR and NRC Region III staff, and the Exelon Generating Company (Exelon). The purpose of this meeting was to discuss Exelon's actions to address issues arising from extended power uprate (EPU) operation at the Quad Cities Nuclear Power Station (Quad Cities) Units 1 and 2. Exelon personnel reviewed EPU issues and their corrective actions, including steam dryer replacements, upgrades to electromatic relief valves, and installation of acoustic side branches to reduce steam line vibrations. Steam dryer replacements are complete at both Quad Cities units and at Dresden Nuclear Power Station (Dresden) Unit 3. Dresden Unit 2 dryer will be replaced during its fall 2007 refueling outage. The NRC staff indicated that it has not identified any issues that prevent Exelon continuing full EPU operation at Quad Cities and Dresden. Exelon plans to submit a letter in April 2007 documenting its ongoing EPU issues corrective actions commitments.

Waterford 3 - Public Meeting on Steam Generator Batwing Degradation Issue

On March 22, 2007, NRC staff met with Entergy at NRC's office in Rockville, Maryland to discuss the technical understanding of the steam generator batwing degradation condition, to review analyses supporting safe plant operation, to review the mitigation actions taken, and to discuss Entergy's plans for a mid-cycle outage to inspect the steam generator batwings and their support structures. Based on its understanding of the potential impact of the batwing degradation condition on tube integrity, Entergy has concluded that inspections on the secondary side of the steam generators should be sufficient to assure plant safety. Entergy will be prepared to conduct primary site inspections, if needed. The mid-cycle outage will occur in the fall of 2007.

Honeywell Licensee Performance Review

On March 21, 2007, NMSS staff, along with Region II Senior Management, conducted a public meeting to formally present the findings of the 2006 Licensee Performance Review for the Honeywell uranium conversion facility. The meeting was held at the Community Center in downtown Metropolis, Illinois. The meeting was attended by plant personnel from Honeywell and members of the public.

Conclusion of American Centrifuge Plant Mandatory Hearings

On March 21, 2007, the Atomic Safety and Licensing Board (Board) completed its mandatory hearing for the USEC Inc. (USEC) American Centrifuge Plant. The Board considered a range of safety and environmental issues associated with the construction, operation, and decommissioning of the proposed facility, during the 3-day hearing. It is expected to render its findings on whether to grant or deny a license to USEC by April 13, 2007.

Staff Observe Audit of U.S. Department of Energy (DOE) Technical Data Management System

On March 22, 2007, staff completed an observation of a DOE, Office of Civilian Radioactive Waste Management, Office of Quality Assurance audit of the Technical Data Management System. The audit was conducted in Las Vegas, Nevada. Its objectives were to evaluate the effectiveness of the processes for controlling technical data, the timeliness of data submittal to the Project's Technical Data Management System, and the traceability of submitted data to the processes and products that reference the data. The NRC observers assessed the effectiveness of DOE's audit team and the audit process, in achieving the audit objectives.

Final Interim Staff Guidance on Level of Design Detail and Estimating Reliability

On March 22, 2007, a notice was published in the *Federal Register* (72 FR 13534) that responded to public comments on draft Interim Staff Guidance, "Preclosure Safety Analysis - Level of Information and Reliability Estimation." The interim guidance clarifies review guidance in NUREG-1804, "Yucca Mountain Review Plan." Both the notice and final guidance HLWRS-ISG-02 are in the NRC's Agencywide Documents Access and Management System; the accession number is ML070260204.

NRC and the DOE Quarterly Management Meeting

On March 27, 2007, NRC and DOE staffs held a "Quarterly Management Meeting" on the DOE high-level waste program. Discussions included program updates and quality assurance issues, such as the DOE root-cause analysis regarding U.S. Geological Survey e-mails. The meeting was open to the public and was attended by interested parties, stakeholders, and members of the press.

<u>Public Meeting with Holtec International to Discuss the HI-STORM 100U Design Concept Certificate of Compliance Amendment Application and Structural Issues</u>

On March 27, 2007, NMSS staff met with representatives from Holtec International (Holtec) to discuss the licensee's plans for resubmittal of a request for approval of the HI-STORM 100U underground design concept. The meeting was held to discuss Holtec's response to structural issues, identified during the NRC's staff review of a proposed amendment to the HI-STORM 100 Certificate of Compliance, to incorporate the HI-STORM 100U that was withdrawn by Holtec in late 2006. The withdrawal was predicated on staff concerns that seismic analyses performed for the HI-STORM 100U would not adequately reflect potential site conditions. At the meeting, Holtec presented new and revised structural analyses in response to the staff's concerns. The staff responded positively to the material presented by Holtec and indicated that it appeared the staffs concerns had been addressed. A new application is scheduled to be submitted by the end of April 2007.

Completion of Regulatory Guides for Use in New Reactor Licensing

On March 28, 2007, the staff completed the publication of the high-priority regulatory guides (RGs) which needed to be completed in March 2007 to support new reactor licensing activities. In July 2006, the staff had identified 31 RGs to be revised or developed by March 2007 to support new reactor licensing activities. Two were later identified as exceptions and not to be completed by March 2007. One is the proposed revision to RG 1.93, "Availability of Electric Power Sources," which was subsequently evaluated and determined to not be needed and withdrawn. The second is completion of RG 1.206, "Combined License Applications for Nuclear Power Plants (LWR Edition)," which is being delayed until after incorporation of Commission comments related to the final Part 52 rule. In the interim, certain sections of RG 1.206 will be released for preliminary use prior to final publication of the RG. This completes the staff efforts with the high-priority regulatory guides. The staff will now begin work on the next phases of regulatory guides revision and development in accordance with the plan to review and update, as necessary, all regulatory guides.

Project on Government Oversight and Union of Concerned Scientists (PRM-50-83)

On March 29, 2007, the NRC published a document in the *Federal Register* (72 FR 14713) that requests comment on a petition for rulemaking submitted by the Project on Government Oversight and Union of Concerned Scientists (PRM-50-83). The petitioners request an amendment that would require periodic demonstrations by applicable local, State, and Federal authorities to ensure that nuclear power plants can be adequately protected against radiological sabotage greater than the design basis threat. The comment period for this action closes June 12, 2007.
