Request to Cancel By-Product Material License No. 06-11682-02

Pursuant to 10 CFR 30.36(d), Connecticut Yankee Atomic Power Company (CYAPCO) hereby requests to cancel the Haddam Neck Plant (HNP) By-Product Material License No. 06-11682-02.<sup>1</sup> The subject By-Product Material License allows CYAPCO to receive, possess, and handle radioactive material at temporary locations outside the boundaries of the HNP site.

All of the activities involving radioactive materials on the Haddam Neck Plant site have been controlled by CYAPCO under our 10 CFR 50 license (DPR-61). Occasionally, during the operation of the plant (most recently in November of 1999), CYAPCO has performed work involving radioactive materials outside the boundaries of the HNP site. This work has generally involved the repair of plant equipment or the modification of a waste package containing low levels of radioactive material generated at the HNP site. All of the off-site work of this nature has been performed under the subject, Part 30 license and controlled by the CYAPCO Radiation Protection staff.

In all cases, all of the contaminated items and any materials potentially contaminated in the off-site work were returned to the HNP for reinstallation in the plant or disposal under CYAPCO's Part 50 license. The off-site facilities were subsequently surveyed by trained CYAPCO Health Physics Technicians to insure that no detectable plant related radioactivity was left.


NMSS/RGN1 MATERIALS-002



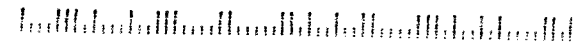
