Subject: Change in Reporting Requirements for Annual Financial Report

Reference: 10 CFR Parts 50 and 72 (RIN 3150-AH39), "Submission of Annual Financial Reports: Elimination of Requirement," (71 Fed. Reg. 29244), dated May 22, 2006

In the above reference, reporting requirements for the Annual Financial Report, specified in 10 CFR 50.71, "Maintenance of records, making of reports," paragraph (b), and in 10 CFR 72.80, "Other records and reports," paragraph (b), have been revised. The revised regulations, which became effective on August 7, 2006, now indicate that licensees and holders of a construction permit who submit a Form 10-Q with the Securities and Exchange Commission (SEC) or a Form 1 with the Federal Energy Regulatory Commission, need not submit an annual financial report or a certified financial statement pursuant to those paragraphs.

Exelon Corporation is a utility holding company that operates through its principal subsidiaries, Commonwealth Edison Company, PECO Energy Company, and Exelon Generation Company, LLC (EGC). Exelon Corporation and its subsidiaries are United States SEC registrants and file a combined quarterly financial report, Form 10-Q, and an annual financial report, Form 10-K, with the SEC. EGC is the licensee for Braidwood, Byron, Dresden, LaSalle, Limerick, Peach Bottom, Quad Cities, and Zion nuclear stations; and AmerGen Energy Company, LLC (AmerGen), a wholly owned subsidiary of EGC, is the licensee for Clinton, Oyster Creek and TMI nuclear stations. The financial information for EGC's ownership interests in the 11 nuclear stations listed above is consolidated in the quarterly EGC Form 10-Q and annual Form 10-K SEC filings.


EGC has concluded that the quarterly filing of the Exelon Corporation Form 10-Q, and annual filing of the Exelon Corporation Form 10-K to the SEC meets the requirements of the revised 10 CFR 50.71(b) and 10 CFR 72.80(b); therefore, EGC will no longer submit annual financial reports for either EGC or AmerGen.
