The purpose of this task order modification is to (1) extend the period of performance from March 31, 2007 to June 30, 2007 at no additional cost and to; (2) revise the TAC number from MC8375 to MD1481. Accordingly, the task order is hereby modified as follows:

1. Paragraph two (2) of the definitization letter is hereby deleted in its entirety and replaced with the following:

“Task Order No. 025 shall be in effect from May 15, 2006 through June 30, 2007, with a cost ceiling of \$91,406.00. The amount of \$84,636.00 represents the estimated reimbursable costs, and the amount of \$6,769.00 represents the fixed fee.”
