The purpose of this modification is to: 1) Exercise Option Period Two, thereby extending the period of performance of the contract from April 22, 2007 through April 21, 2008; and 2) Increase the ceiling amount of the contract by \$1,491,814.64, from \$6,179,140.18 to \$7,670,954.72. Accordingly, the contract is hereby modified:

1. Section B, Subsection B.3 OBLIGATION AND OBLIGATION, paragraph c, first sentence, is deleted in its entirety and substituted with the following in lieu thereof:

“c. The Maximum Ordering Limitation (MOL) for products and services ordered, delivered and accepted under this contract is \$7,670,954.72.”

2. Section F, Subsection F.3 DURATION OF CONTRACT PERIOD, is deleted in its entirety and substituted with the following in lieu thereof:

“The ordering period for this contract shall commence on April 22, 2003 and will expire on April 21, 2008. Any orders issued during this period shall be completed within the time specified in the order, unless otherwise specified herein. (See 523.216-18 - Ordering.)”

All other terms and conditions of the contract remain the same.
