In accordance with your application dated January 25, 1993, and pursuant to Part 40 to Title 10 of the Code of Federal Regulations, Materials License SMB-743 is hereby amended to reflect administrative changes regarding the radiation protection program and authorized users. Accordingly, Condition 10 is revised to include the date of January 25, 1993, and Condition 12 is amended as follows:

Condition 12 Licensed material shall be used by, or under the supervision of, David R. Smith, Bill Grabus, Knud Clausen, Brian Martin, Al Lashley, Richard Bodine, Robert A. DeGrange, Robert Nesbitt, or Eli Medina. Overall control and authority for radiological protection shall be with the Senior Vice President of Manufacturing. The Radiation Safety Officer shall be Mr. Craig Rieman. The Assistant Radiation Safety Officer shall be Mr. James P. Valenti.

Please note that, due to a reorganization at the Nuclear Regulatory Commission, we have reformatted your license.
