Enclosed is Amendment No. 02 to your NRC Material License No. 24-32595-01 in accordance with your request. Please note that the changes made to your license are printed in **bold** font.

Please review the enclosed document carefully and be sure that you understand all conditions.

Please note that I was unable to approve Ted Moore, M.D. as an authorized user for the use of material in 10 CFR 35.100 and 35.200 at this time because the information in your letter dated January 25, 2007, was insufficient to complete my review. If you wish to pursue this matter, please submit the information requested, addressed to my attention and referenced as "additional information to control number 315989." We will then continue our review.

Specifically, Dr. Moore was not approved as an authorized user because, contrary to the assertion made in your letter dated January 25, 2007, Dr. Moore was not named to the license number given, 15-26381-01. I checked this license back to its origin and no Dr. Moore was ever named on it.

Please submit written information demonstrating that Dr. Moore meets the regulatory requirements in 10 CFR 35.13, 35.14, 35.57, 35.59, 35.190 and 35.290, as appropriate.

Please refer to the above regulatory requirements as well as section 8.11, item 7 and Appendices B, D and E in NUREG 1556, Vol. 9, Rev. 1, for assistance in preparing your response.

conditions to be maintained by the applicant or the licensee shall be complete and accurate in all material respects."

You will be periodically inspected by NRC.
