I have confirmed with Leslie Fields that because the GE/HON deal fell through, Honeywell is still required to submit NRC decommissioning cost for the Metropolis NRC license for year 2000. As you will recall, our decommissioning cost for 2000 was included in the paperwork that GE/HON submitted for potential transfers of all active NRC licenses.

As previously discussed with Marshall and Hugh, they have confirmed the annual decommissioning costs for Metropolis NRC license to be as follows:

2000 - \$99.5M 2001 - \$103M
