From our discussion on the phone, Ohio is aware of the extended time NRC will need to fill our order from March 15, 2007. Ohio's immediate need would be to re-supply the KI for Emergency Workers and Institutionalized populations.

I am writing to request an expedited process in obtaining Potassium Iodide (KI) for use by institutionalized populations and emergency workers in Ohio that are in the 10 mile emergency planning zone (EPZ) for the following nuclear power plants:

- 1. Beaver Valley Nuclear Power Plant: The population Ohio is responsible for is in Columbiana County, Ohio and the city of East Liverpool, Ohio. Emergency workers and institutionalized populations are 1,500.
- 2. Perry Nuclear Power Plant: The population Ohio is responsible for is in Lake County, Geauga County, and Ashtabula County. Emergency workers and institutionalized populations are 8,700.
- 3. Davis-Besse Nuclear Power Station: The population Ohio is responsible for is in Ottawa County and Lucas County. Emergency workers and institutionalized populations are 1,500.

The total KI for this request is for populations that include: 1,500 + 8,700 + 1,500 = 11,700The total number of KI tablets for this request is:  $11,700 \times 7$  tablets per each = <u>81,900</u> (130 mg tablets). This would be the more appropriate tablet size for this adult population. Ohio has a more immediate need for these tablets than it does for the entire population in the 10-mile EPZ which has been extended for two years.
