

The purpose of this modification is to provide incremental funding in the amount of \$49,000.00, thereby increasing the amount obligated from \$334,964.00 to \$383,964.00. Accordingly, the contract is hereby modified:

Subsection B.2, CONSIDERATION AND OBLIGATION, paragraph (b), first sentence, is deleted and substituted with the following in lieu thereof:

“(b) The amount presently obligated with respect to this contract is \$383,964.00.”
