SECY-07-0063 Issued

On April 3, 2007, the staff issued SECY-07-0063, "Fiscal Year (FY) 2006 Results of the Industry Trends Program," to document the results and analysis of the FY 2006 industry-level performance indicators. The report also summarizes the status of the ongoing development of the Industry Trends Program. The report concludes that no statistically significant adverse industry trends have been identified through FY 2006. In addition, no issues that warranted further analysis or significant program adjustments were identified by short-term trending of the FY 2006 data.

Meeting with Exelon Generating Company Regarding LaSalle County Station

On April 5, 2007, the staff met with members of Exelon Generating Company for a public meeting to discuss a pre-application license amendment for LaSalle County Station (LaSalle) for the Ultimate Heat Sink (UHS). On November 3, 2006, the staff issued a notice of denial which documented that the LaSalle's initial March 13, 2006, amendment request to be unacceptable. The purpose of the April 5 meeting was to discuss the action items identified during the denial followup meeting held on January 26, 2007. The licensee plans to resubmit a license amendment request for the UHS on or before May 31, 2007.

Reactor Oversight Process Self-assessment SECY Paper Issued

On April 6, 2007, the staff issued SECY-07-0069, "Reactor Oversight Process (ROP) Self-assessment for Calendar Year (CY) 2006," to document the self-assessment results for CY 2006. The results for CY 2006 indicate that the ROP provided effective safety oversight as demonstrated by meeting the seven program goals and achieving its intended outcomes. The NRC appropriately monitored operating nuclear power plant activities and focused agency resources on performance issues, and plants received a level of oversight commensurate with their performance. The staff continued to emphasize stakeholder involvement and improve various aspects of the ROP as a result of feedback and lessons learned.

Reactor Oversight Process Monthly Meeting

On April 11, 2007, the staff held the monthly Reactor Oversight Process (ROP) public meeting. The purpose of this meeting was to provide a forum for industry feedback on staff initiatives. The meeting attendees discussed mitigating systems performance index (MSPI) implementation, safety culture integration into the reactor oversight process, performance indicator issues, and open and new frequently asked questions for the ROP.

National Institute of Standards and Technology (NIST) Annual Fire Research Conference

On April 4-5, 2007, the staff made presentations at the above-mentioned conference which was attended by more than 140 U.S. and international fire researchers. The RES Fire Research Team discussed its Fire Modeling Verification and Validation program and Cable Response to Live Fire (CAROLFIRE) spurious actuation testing program.

Federal Agencies Fire Research Working Group Sponsored by NIST

On April 6, 2007, NIST sponsored a meeting attended by about 100 personnel representing 12 Federal Agencies. Discussions during the meeting, which was held at the request of RES, focused on how multiple agencies could benefit from the various fire research programs being conducted. NIST and RES were tasked to draft a charter for a Federal Fire Safety Research working group, and NIST was tasked to establish a web-based forum for this group to communicate and exchange information.

Request for Comments on Petition for Rulemaking submitted by the Union of Concerned Scientists (PRM-73-13)

On April 9, 2007, the NRC published a document in the *Federal Register* (72 FR 17440) that requests comments on a petition for rulemaking submitted by the Union of Concerned Scientists (PRM-73-13). The petitioner requests an amendment to the regulations that would close a loophole in the access authorization regulations. The amendment would prevent persons who do not meet trustworthiness and reliability standards from unescorted access to protected areas of nuclear power plants. The comment period for this action closes June 25, 2007.
