The purpose of this modification is to: 1) Exercise Option Year Three of the contract to extend the period of performance through November 30, 2007, effective December 1, 2006; 2) Increase the ceiling amount by \$49,571.48 from \$228,460.02 to \$278,031.50; and Increase the amount obligated in the contract, by \$49,600.00, from \$180,332.38 to \$229,932.38. Accordingly, the contract is hereby modified:

1. Section B.1 CONSIDERATION AND OBLIGATION–DELIVERY ORDERS, first sentence of paragraphs (a) and (b), as modified in Modification No. 8, are revised to read as follows:

"(a) The total estimated amount of this contract (ceiling) for the products/services ordered, delivered, and accepted under this contract is \$278,031.50."

(b) The amount presently obligated with respect to this contract is \$229,932.38."

2. Section C.12 DURATION OF CONTRACT PERIOD, is deleted in its entirety and substituted with the following in lieu thereof:

"The ordering period for this contract shall commence on December 1, 2003 and shall expire on November 30, 2007"
