Shirley,

Penny Lanzisera passed on your request for assistance to find a contact for Brick PET Partners, LN 29-30692-01. I understand that you are planning to revoke this license for non-payment of fees.

I tracked down the RSO, Dr. Diane Connors, who is employed at NJ Diagnostices and Women's Therapy at 455 Jack Martin Blvd in Brick, NJ. She was not available, but I was able to speak to Dr. Kaplan, also listed as an authorized user on the Brick PET license. (Isn't the internet wonderful...so easy to find these folks).

Dr. Kaplan explained the Brick PET is out of business and no longer at that location. I discussed our concerns with Dr. Kaplan of 1) non-payment of fees, and more importantly 2) we need to verify that the calibration sources were appropriately transferred/disposed of. He said he would make some calls and get back to me.

Dr. Kaplan called me back a few minutes ago, and said he spoke with Jason DeSalvo, who was a partner in Brick PET. (He was listed as the President in our licensing documents.) Mr. Salvo told him that the closure of the facility was overseen by their medical physics consultant, and he believed that all sources were properly transferred etc. however, the consultant is out of the country this week and will not be back until next week. Mr. DeSalvo also told Dr. Kaplan that he believed all required paperwork was filed. I told Dr. Kaplan we would follow up on this. Also, I asked Dr. Kaplan to discuss this with Dr. Connors, who is the RSO of record for Brick PET.
