

The purpose of this modification is to provide funding in the amount of \$87,000.00, thereby increasing the obligated amount in the contract from \$549,623.00 to \$636,623.00. Accordingly, the contract is modified as follows:

Section B.2, Consideration and Obligation—delivery orders (JUN 1988), the first sentence in paragraph (b), as modified in Modification No. 6, is deleted and substituted with the following in lieu thereof:

“(b) The amount presently obligated with respect to this contract is \$636,623.00.”

This modification obligates fiscal year 2007 funds in the amount of \$87,000.00.
