




3. In accordance with the license, the licensed material shall be used by or under the supervision of Ilse Stoll, Stephanie Olexa and Christopher Medei.

6. We will assure historical traceability of the License number and will commit to maintaining all records for a minimum of five years and make these records available for inspection.




