SUBJECT: RESPONSE TO YOUR LETTER DATED JANUARY 10, 2007, REQUESTING
COPIES OF DOCUMENTS REGARDING THE SHIELDALLOY
METALLURGICAL CORPORATION FACILITY, NEWFIELD, NEW JERSEY

Dear Mr. Westergaard:

I am responding to your letter dated January 10, 2007, requesting copies of documents related to the Shieldalloy Metallurgical Corporation (SMC) facility in Newfield, New Jersey. In early February 2007, Mark Roberts, NRC Region I inspector for the SMC facility, discussed this request with you and provided information regarding the NRC's Agencywide Documents Access and Management System (ADAMS). The publically-available ADAMS electronic database is available from the NRC public website at <http://www.nrc.gov>.

As Mr. Roberts discussed with you, in order to make publically available agency documents that pre-date the establishment of the ADAMS electronic database (April 1, 2000), Region I staff needed to identify and collect relevant SMC documents from our paper files that were not in the ADAMS electronic database, scan each document to create an electronic image, and profile these document images for input into ADAMS. This labor-intensive effort is essentially complete, resulting in the addition of over 400 SMC documents to the publically available ADAMS database. The enclosure to this letter provides guidance for accessing SMC documents in the NRC's ADAMS electronic database.

Your letter included requests for a number of categories of documents including, but not limited to, air, water, and soil sampling and analysis data; historical inspection reports, including any violations that may have been cited; correspondence sent to the company or other agencies; and information regarding characteristics of the onsite slag. We believe that the information you have requested, as available in NRC documents, is now present in ADAMS and can be accessed by you by following the enclosed instructions.

INSTRUCTIONS FOR ACCESS TO THE NRC PUBLIC DATABASE (ADAMS)

Access the NRC public website at <http://www.nrc.gov>.

Scroll to the box marked "Electronic Reading Room" on the left-hand side of the NRC homepage.

From this box, Select "Adams Documents" to bring up the ADAMS access webpage.

From the ADAMS webpage, select "web-based access".

From this page select "Begin ADAMS Search".

To access Shieldalloy Metallurgical Corporation (SMC) documents, type in "04007102", the NRC unique docket number for SMC into the SEARCH Box and then select "search".

This will bring up a listing of documents by Title, Accession Number, and Document Date and a page count for each document. The Accession Number is the NRC unique identification number for each document in the database system.

To view an actual document image, click on the ".pdf" icon under the Image file column.
