
14. DESCRIPTION OF AMENDMENT/MODIFICATION (Organized by UCF section headings, including solicitation/contract subject matter where feasible.)

The purpose of this modification is to 1) extend the period of performance; 2) provide incremental funding and 3) increase the ceiling amount of Task Order No. 11 under NRC-10-04-398.

1) The period of performance is hereby extended from May 31, 2007 to July 31, 2007. FAR 52.217-8 applies.
2) Funds are hereby obligated in the amount of \$9,000.00. 3) The ceiling is increased by \$9,000.00 from \$138,000 to \$147,000.00.

FY04 Obligations: \$8,000.00; FY05 Obligations: \$51,000.00
FY06 Obligations: \$49,000.00; FY07 Obligations: \$39,000.00
Total Obligations: \$147,000.00
