
Dear Sir or Madam:

In accordance with the Nuclear Regulatory Commission's (NRC) letter (enclosure) dated 3 April 2007, signed by Ms. Sandra Gabriel, and in accordance with 10 CFR 35.14 (b), effective 21 May 2007, Captain Gary L. Hall will no longer serve as the Radiation Safety Officer (RSO) for NRC License Number 39-14873-01 at Moncrief Army Community Hospital, Fort Jackson, South Carolina.
