2) Physical Description

This shipment consists of 22 x 48Y Cylinders loaded on one lash barge. RADIOACTIVE MATERIAL, URANIUM HEXAFLUORIDE, non fissile or fissile-excepted. Total net weight of U is 180,605 kgs. The net weight of U-235 is 1,276 kgs.

3) Transportation and Route Schedule

The surface transportation from Metropolis, IL to Paducah, KY will be the responsibility of TAM International Inc. The US inland waterway transportation from Paducah, KY to New Orleans, LA will be the responsibility of Excell Marine. The ocean transportation from New Orleans, LA to Rotterdam, The Netherlands will be the responsibility of Forest Line Inc. 
