The purpose of this blanket purchase agreement (BPA) modification is to extend the period of performance from July 31, 2007 to December 31, 2007 at no cost. Accordingly, section A.2 TERM OF THE BPA is hereby modified as follows:

"This BPA expires on 12-31-2007 or such later date as determined by the exercise of any "General Schedule extension" option by the GSA and exercise of the option to extend the term of the BPA by the U.S. Nuclear Regulatory Commission/CO. The BPA holder is required to immediately notify, in writing, the U.S. Nuclear Regulatory Commission/Contracting Officer if at any time prior to 12-31-2007 the GSA Contract, upon which this BPA is based, is no longer in force. This BPA is not a contract. If the BPA holder fails to perform in a manner satisfactory to the U.S. Nuclear Regulatory Commission Contracting Officer, this BPA may be canceled within 15 days written notice to the BPA holder by the U.S. Nuclear Regulatory Commission Contracting Officer."

This modification does not obligate any funds.

All other terms and conditions of the blanket purchase agreement remain unchanged.
