Enclosed please find our final report for grant no. NRC-06-05-303. We have concluded that the Gateway Mill Site, NRC license no. R-00215 (formerly R-00170), Sinbad Uranium Corporation (George E. Davis), is ready for license termination and file closure.

By this letter, the Colorado Department of Public Health and Environment directs NRC to terminate AEC/NRC Radioactive Materials License R-00215 (previously R-00170) and close its file on the matter. This Department will now exercise its authority to file and enforce restrictive covenants on the property with respect to remaining contamination, in accordance with Colorado law.

As I understand it, this report now satisfies all requirements for the grant. You have previously received payment vouchers on Form SF-270 totaling \$865,588.42 for the entire amount of the grant.

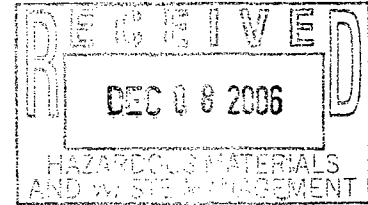
