MEETING SUMMARY

SUBJECT: SUMMARY OF MAY 14, 2007 ANNUAL ASSESSMENT MEETING WITH
ENTERGY NUCLEAR OPERATIONS, INC.

On May 14, at 6:00 p.m., an Annual Assessment Meeting was conducted at the Quality Inn, Brattleboro, Vermont, between the Nuclear Regulatory Commission (NRC) and Entergy Nuclear Operations, Inc. (Entergy). The NRC requested the meeting with Entergy management to discuss the NRC's assessment of the safety performance of Vermont Yankee Nuclear Power Station (Vermont Yankee) for the calendar year 2006.

The NRC presented and discussed its assessment of the safety performance of Vermont Yankee for the period between January 1 through December 31, 2006. The NRC presentation included information on the Reactor Oversight Program (ROP), summary of national performance assessment results, and the results of NRC's performance assessment for Vermont Yankee. As part of this regulatory performance meeting, Entergy presented its perspective regarding the plant's performance and operation goals for 2007.

The public observed this meeting and was offered the opportunity to communicate with the NRC regarding Entergy's performance at Vermont Yankee and the role of the agency in ensuring safe plant operations. At the end of the meeting between the NRC and Entergy, public attendees were offered the opportunity to ask questions of NRC officials. Questions raised by members of the public and local media were also addressed by the NRC.
