SUBJECT: SUMMARY OF MAY 17, 2007, CATEGORY 2 MEETING ON  
FREQUENTLY ASKED QUESTION PROCESS REGARDING  
NATIONAL FIRE PROTECTION ASSOCIATION STANDARD 805

On May 17, 2007, the U.S. Nuclear Regulatory Commission (NRC) staff held a meeting with stakeholders and the public to discuss frequently asked questions (FAQs) at plants that are adopting National Fire Protection Association Standard 805. Licensees introduced and discussed revised versions of nine FAQs at this meeting and introduced two new FAQs. The staff presented and discussed written responses to three FAQs. Licensees and NRC staff also discussed the remaining open FAQs. The staff and licensees achieved final closure on two FAQs, and agreed to begin the closure process for two others. The participants determined that both industry stakeholders and the NRC staff needed to continue to work on the remaining open FAQs.

All participants agreed that the next monthly meeting should occur on June 21, 2007, via teleconferencing, that the July meeting should occur on July 19, 2007, at Nuclear Energy Institute (NEI) headquarters, and that the August meeting should take place on August 23, 2007, via teleconferencing.

The new FAQs, revised FAQs, and written responses introduced at the meeting are available in the Agencywide Documents Access and Management System. The accession numbers for the revised FAQs are ML071080099, ML071340180, ML071340184, ML071340188, ML071340192, ML071340194, ML071340195, ML071350432, and ML071380229.
