

AFFIDAVIT


I, Brian P. O'Connor, Chief Security and Privacy Officer, and Vice President, Legal Division of Eastman Kodak Company ("Kodak"), do hereby affirm and state:

1. I am authorized to execute this affidavit on behalf of Kodak, and
2. Kodak is providing information to the Nuclear Regulatory Commission in the form of *Nextep Technical Memorandum 06-05, Subject: Kodak CFX Decommissioning Environmental Report (Revision 1, January 2007)*. This Technical Memorandum concerns the decommissioning of a CFX research reactor. Pages 1-7 of the Memorandum contain proprietary commercial information that should be held in confidence by the NRC pursuant to the policy reflected in 10 CFR 2.390(a)(4) and 9.17(a)(4), because:
 - i. This information is and has been held in confidence by Eastman Kodak Company.
 - ii. This information is of a nature that describes the type, quantity, location, enrichment levels, and physical security characteristics of special nuclear material of moderate strategic significance, which is owned by Kodak.
 - iii. This information is not available in public sources and could not be gathered readily from other publicly available information.
 - iv. This information is being submitted to the NRC voluntarily and in confidence.
 - v. Public disclosure of this information could pose a threat to the employees of Kodak and a threat to national security by making available the details of this highly enriched nuclear material to the general public.
3. Accordingly, Eastman Kodak Company requests that the sections of the above referenced Environmental Report identified as "Proprietary Information", be withheld from public disclosure pursuant to the policy reflected in 10 CFR 2.390(a)(4) and 9.17(a)(4).
