SUBJECT: SAFETY LIGHT CORPORATION, CONSENT TO THE WITHDRAWAL OF
DECOMMISSIONING TRUST FUNDS, CONTROL NOS. 140597 AND 140598

Dear Mr. Lynch:

This refers to the letter dated June 6, 2007, requesting written consent to commit and withdraw additional funds from the NRC-controlled decommissioning trust fund. We understand that this is needed to complete the payment for the characterization of tritium wastes from pre-2000 licensed activities and disposal of the high-activity tritium wastes from pre-2000 licensed activities. In our letter dated May 19, 2006, we authorized you to withdraw a maximum of \$300,000 from the decommissioning fund for these activities. We understand that you require an additional \$24,000 to cover the actual costs, which exceeded your original estimate.

Because the characterization and disposal of tritium wastes from pre-2000 licensed activities is essential to the successful closure of activities at the site by December 2007, this expenditure falls within the provisions of Condition 19.A. of your license. Accordingly, you are authorized to use a maximum of \$324,000 of the decommissioning trust fund to pay for work done to characterize the tritium wastes from pre-2000 licensed activities and to dispose of the high-activity tritium wastes from pre-2000 licensed activities. You should plan to keep this office informed of your expenditures and progress in characterization and waste disposal as activities proceed.
