Enclosed is Amendment No. 53 to your NRC Material License No. 24-08960-02 in accordance with your request. Please note that some of the changes made to your license are printed in **bold font**.

Please be sure that you understand all conditions. If there are any errors or questions, please notify the U.S. Nuclear Regulatory Commission, Region III office at (630) 829-9887 so that we can provide appropriate corrections and answers.

**Please note that I was unable to approve Avril Slavin, M.D. as an Authorized User for materials in 10 CFR 35.100, 35.200 and 35.300 at this time because the information in your letter dated March 2, 2007, was insufficient to complete my review. Please submit the information below and respond in writing, referencing "additional information to control number 316082" and put it to my attention. We will then continue our review.**

**In support of Dr. Slavin's application to become an Authorized User, you submitted an undated "Radioactive Materials User Permit" showing Dr. Slavin was authorized for the use of materials in 10 CFR 35.200 and 35.500. Please submit a copy of this permit showing the dates when Dr. Slavin became an Authorized User.**

**Please also note that the uses requested for Dr. Slavin do not correlate completely with your request, i.e., she has requested authorization for the use of materials in 10 CFR 35.100 and 35.300 but her permit from the referenced licensee did not include these authorizations. Please submit information showing that Dr. Slavin is qualified to use these materials.**

**Please refer to the regulatory requirements in 10 CFR 35.35.190, 35.390, 35.57, 35.13 and 35.59, as well as section 8.11, item 7 and Appendices B, D and E in NUREG 1556, Vol. 9, Rev. 1, for assistance in preparing your written response to demonstrate that Dr. Slavin's training and experience meet the appropriate regulatory requirements for the modalities she seeks authorization for.**

**This also refers to the telephone discussion between you and me on June 5, 2007, concerning the total activity authorized by Subitem No. 8.E. of your license. In this conversation you authorized me to reduce the activity of one of these sources from 10 to 8 curies. Your amendment has been prepared accordingly.
