Subject: Safeguards Access Request

Westinghouse is submitting a revised copy of the "AP1000 Nuclear Plant Project Control of Safeguards Information" procedures numbered APP-GW-GAP-300 Revision 3 to the Nuclear Regulatory Commission (NRC) as a follow-up to the NRC inspection of the Westinghouse Security facility and procedures on June 12, 2007. At the request of the NRC any mention to or approval of Temporary Safeguards Access has been removed from the procedures. The updated procedures only allow for Safeguards Access to be obtained on a permanent basis once the results from the NRC fingerprint check are returned. Additionally, the Open / Close Safe Log and Temporary Safeguards Information Inventory and Activity sheets have been removed from the procedure. Westinghouse appreciates the NRC's corporation in expediting Westinghouse's authorization to independently control Safeguards Information.
