MEMORANDUM AND ORDER
(Scheduling Initial Prehearing Conference)

Pursuant to the Licensing Board's June 13, 2007 memorandum and order, the Board has been advised by the participants that, after consulting among themselves, not all the participants are available for the proposed June 20 or 21, 2007 initial prehearing conference dates. Additionally, however, the participants have indicated they would be available on two days the week of July 9, 2007, the alternative time period suggested by the Board. After considering the dates proffered by the parties, the Board has decided to schedule the conference as follows:
