SUBJECT: LICENSE AMENDMENT

Please find enclosed Amendment No. 85 to NRC License No. 42-00090-03 **authorizing a sealed source holder device in Items 7.JJ and 9.JJ.**

Please note that by License Condition 19 you are required to comply with the “Increased Controls for Licensees that Possess Sources Containing Radioactive Material Quantities of Concern” (IC) (ADAMS Accession No. ML053130364) published as “Attachment B” to the “Orders Imposing Increased Controls” (ML053130218) in the Federal Register on December 1, 2005 (70 FR 72128). This License Condition requires you to complete implementation of said requirements by the first day that radionuclides in quantities of concern are possessed at or above the limits specified in “Table 1: Radionuclides of Concern” found in the IC, and notify, in writing, the Director, Office of Federal and State Materials and Environmental Management Programs, U.S. NRC, Washington, DC, 20555, when you have completed the requirements of this License Condition. Your response must be marked as "Withhold from Public Disclosure Under 10 CFR 2.390."

NRC's Regulatory Issue Summary (RIS) 2005-31, provides criteria to identify security-related sensitive information and guidance for handling and marking of such documents. This ensures that potentially sensitive information is not made publicly available through ADAMS. Pursuant to NRC's RIS 2005-31, the enclosed materials license will not be made publicly available.

An environmental assessment for this action is not required, since this action is categorically excluded under 10 CFR 51.22(c)(14)(xi). You should review the enclosed document carefully and be sure that you understand all conditions. If there are any errors or if you have any questions, please contact me at 925-673-9646.

In addition, please note that NRC Form 313 requires the applicant, by signature, to verify that the applicant understands that all statements contained in the application are true and correct to the best of the applicant's knowledge. The signatory for the application should be the licensee or certifying official rather than a consultant. Since the NRC also accepts a letter requesting amendment of an NRC license, the signatory for such a request should also be the licensee or certifying official rather than a consultant.

NRC will periodically inspect your radiation safety program. Failure to conduct your program according to NRC regulations, license conditions, and representations made in your license application and supplemental correspondence with NRC may result in enforcement action against you. This could include issuance of a notice of violation; imposition of a civil penalty; or an order suspending, modifying, or revoking your license as specified in the NRC Enforcement Policy.
