Dear Sir or Madam:

On April 30, 2007, by way of letter W3F1-2007-0022, per 10CFR20.2206(b) and (c), Entergy notified the NRC that the annual report of the results of individual monitoring by Waterford 3 for individuals for whom monitoring was required had been provided to the NRC by electronic media. Subsequent reviews by Waterford 3 personnel identified that some required monitoring data was not included in the electronic uploading of data to the REIRS website (<https://www.reirs.com/submit/submitdata.cfm>) for annual reports uploaded since approximately year 2000, coincident with the conversion from ERIMS to HIS-20. The report discrepancies have been brought to the attention of Waterford 3's NRC Project Manager and to the attention of the appropriate NRC resource personnel. As allowed by Regulatory Guide 8.7, the information that was inadvertently omitted from the April 30, 2007 has been uploaded under file name Composite_Frm5.DAT at the address: <https://www.reirs.com/submit/submitdata.cfm> on June 14, 2007.

Waterford 3 condition reports (CR-WF3-2007-01597 and CR-WF3-2007-01947) have been generated to address the above mentioned omission of monitoring data from annual reports.

The inadvertently omitted monitoring data constituted individual exposures that were well below 10% of the annual limit (5 REM) for each of the years involved. Consequently, none of the NRC Form 5s required reporting of exposure amounts.
