Roy Zimmerman, our head of security and incident response, to do the interview because of Roy's broad knowledge of the subject matter.

Because we lack really decent facilities here for a studio-like interview, we'd like to do the taping at your studios down on LaSalle Street, and would ask to do the interview next Thursday morning. That's the time that works out best in Roy's schedule. If you could confirm that as soon as possible I would appreciate it. If Ross is doing the interview in person, I am operating on the assumption that this is a two-camera set up. Please let me know if it is otherwise.

I would also like to walk away with a Beta or VHS copy of the entire interview. If that's not possible, we'd like to do the interview here so we can record it for our own uses or have one of our folks videotape the session at your facilities.

In addition to the video-watching issue we have discussed, I would very much appreciate any heads up in advance of the interview about any specific criticism raised by any specific individual or group so that we can prepare Roy and/or wave you away from using something that is not scientifically sound.

While I know your broad areas of interest, I would also appreciate any more specificity regarding questions you would like to ask during the interview and others you are interviewing.

I still have more background information I need to pass to you that I'm getting prepared, and I expect to have a list of items that I hope you will include in the script.
