RIGHTS OF WAY ENDANGERED SPECIES SURVEY FOR THE CENTRAL REGION OF GEORGIA

The central region consists of the following 26 counties: Spalding, Butts, Jasper, Putnam, Hancock, Monroe, Lamar, Jones, Baldwin, Washington, Bibb, Twiggs, Wilkinson, Peach, Houston, Bleckley, Laurens, Pulaski, Dodge, Wheeler, Wilcox, Telfair, Johnson, Pike, Upson and Crawford.

Based on the Georgia Natural Heritage Inventory records, the following plants, plant communities and animals habitats were searched for on Georgia Power Company rights of way:

Plants:

Alexander rock aster – Aster avitus

Dwarf Chinqua-pin oak – Quercus prinoides

Sweet pitcherplant – Sarracenia rubra

Animals:

American bald eagle(nest) - Haliaeatus leucocephalus (Federal Endangered)

There are no maintenance concerns. Records in Spalding and Monroe counties remain to survey.

<u>Discussion and recommendations:</u> Only 4 locations required field surveys for this region. The small number may be due to the extensive agriculture/timber land use in the area. This region of the state does not have the wetlands found further south and toward the coast or the granite outcrops that occur to the north.

RIGHTS OF WAY ENDANGERED SPECIES SURVEY FOR CENTRAL GEORGIA

All the counties within the Central Georgia Region are summarized below. The GPC numbers is listed along with the common name of the plant/animal.
