Control No. 316129 - Re request to change the Radiation Safety Officer, replacing Peter LeClerc with Garth N. Greenan.


SUMMARY

- In the telephone conversation with Mr. Greenan, we discussed the need to address his qualifications to serve as RSO, based on training which satisfies the criteria in NUREG - 1556, Vol. 1, Rev.1, Section 8.7, "Item 7: Individual(s) Responsible for Radiation Safety Program and Their Training and Experience". Mr. Greenan related that Mr. LeClerc was not only the RSO but also the only authorized user and that since his leaving of the licensee, the licensed material remains unused and in secured storage. Mr. Greenan related that he was considering obtaining training, very shortly, via an online portable nuclear moisture/density gauge training course. However, after discussing the need for a qualified instructor to provide the "hands on training" portion of the required training, Mr. Greenan indicated he would seek to attend a manufacturer's training course scheduled for May 24, 2007, and promptly provide us a copy of the certificate confirming successful completion of the course.
- As the president, Mr. Greenan acknowledged his designation to serve as RSO and his awareness of the duties and responsibilities the position entails.
- Also, I related that we are now required to place on the license as amended, a total possession limit for each radionuclide authorized on the license. Each gauge, of the model of gauge the licensee is authorized to possess (Troxler 3400 series), can have up to 9 millicuries Cs-137 and 44 millicuries of Am-241. Mr. Greenan related that they possess two gauges and although they have no immediate plans for expansion, requested a possession limit to authorize a total of four gauges, i.e., 36 millicuries of Cs-137 and 176 millicuries of Am-241.
