Please note that licensee condition no. 12.B. of your license was modified in accordance with current NRC licensing procedures to remove the statement "limited to cardiovascular procedures". However, please be reminded, that you are still bound by the restrictions imposed by the limited authorizations contained in documents incorporated into condition No.16 of your license.

Also note that Dr. Strabala was added to your license as an authorized user for diagnostic purposes only. The training and experience provided for Dr. Strabala for therapeutic uses was not complete. If you wish pursue this matter in a future amendment, please add to the information already provided, completed sections of NRC Form 313A(AUT) Part 1, section 3.b. and Part II, first section "For 35.394".

Please review the enclosed document carefully and be sure that you understand all conditions. If there are any errors or questions, please notify the U.S. Nuclear Regulatory Commission, Region III office at (630) 829-9887 so that we can provide appropriate corrections and answers.
