**MANAGEMENT CHANGE IN THE DIVISION OF MATERIALS SAFETY AND STATE AGREEMENTS (FSME-07-060)**

**Purpose:** To inform the States of a management change in the Division of Materials Safety and State Agreements, Office of Federal and State Materials and Environmental Management Programs (FSME).

**Background:** On March 21, 2007, Ms. Janice Dunn Lee was appointed the Deputy Director General of the Organization for Economic Co-operation and Development/Nuclear Energy Agency (OECD/NEA). The OECD is an intergovernmental organization of industrialized countries based in Paris, France. The mission of the NEA is to assist its Member countries in maintaining and further developing, through international cooperation, the scientific, technological and legal bases required for the safe, environmentally friendly and economical use of nuclear energy for peaceful purposes. Upon Ms. Dunn Lee's departure, Ms. Margaret M. Doane was appointed to the position of Director, Office of International Programs. Ms. Doane held the position of Deputy Director of the Office of International Programs since 2004.

**Discussion:** On June 15, 2007, Mr. Scott W. Moore was appointed as Deputy Director, Office of International Programs. Mr. Moore joined the NRC in 1988 as a Health Physicist in the Office of Nuclear Material Safety and Safeguards (NMSS). During his career with the NRC, he has held a number of progressively responsible positions including Section Leader in the Division of Industrial and Medical Nuclear Safety and Division of Waste Management; Chief of the Rulemaking and Guidance Branch; and Deputy Director of the Division of Materials Safety and State Agreements, FSME. He also served on rotational assignments in Commissioner McGaffigan's and former Chairman Jackson's offices, as well as Regions I and III. Mr. Moore's interest in NRC's international program stems from his experience representing NRC at International Atomic Energy Agency and Nuclear Energy Agency activities since the late 1990's. Prior to joining the NRC, Mr. Moore began his career in the United States Army, where he served as the Radiation Safety Officer for a community hospital in Ft. Benning, Georgia. Mr. Moore graduated from Cornell University in 1985 with a B.S. in Applied and Engineering Physics. Mr. Moore will transition into his new position in Mid-July 2007. Please join me in congratulating Mr. Moore on his appointment.

The Division of Materials Safety and State Agreements is currently working toward filling the resulting Deputy Division Director position following Mr. Moore's departure. We will notify you once a selection is made.
