Re: Notification of Transfer/Termination of Specific Material License Regarding
Mingo Logan Coal Company License Number 47-25025-01

Pursuant to 10 C.F.R. § 30.34(b), on behalf of Mingo Logan Coal Company ("Mingo Logan"), we write to notify you that Mingo Logan intends to transfer control of the nuclear devices licensed under License Number 47-25025-01 to Cobra Natural Resources, LLC ("Cobra"). In connection therewith, Mingo Logan requests written consent from the U.S. Nuclear Regulatory Commission ("NRC") that License Number 47-25025-01 be transferred to Cobra. In the alternative, based upon conversations with your office and the specific facts surrounding this transaction as explained more fully below, upon the NRC's review of the application for materials license provided by Cobra being submitted simultaneously with this letter, Mingo Logan requests that License Number 47-25025-01 be terminated upon issuance of a materials license to Cobra. In either event, Mingo Logan requests written confirmation from the NRC, upon the NRC's determination, that License Number 47-25025-01 is no longer effective with respect to Mingo Logan.

Mingo Logan currently has materials licenses for devices under License Numbers 47-25025-01 and 47-25025-02. Mingo Logan is selling the business associated with 47-25025-01 to Cobra, and the licensed devices used in the business are included as part of the sale. Your office has advised us that License Number 47-25025-01 cannot be "transferred" because Mingo Logan intends to continue to operate nuclear devices under License Number 47-25025-02. As a result, your office has advised us that, rather than requesting a transfer to Cobra of License Number 47-25025-01, Mingo Logan should instead request that upon the NRC's issuance of a materials license to Cobra, Mingo Logan's License Number 47-25025-01 be terminated.

Please accept this letter and Cobra's application for materials license as a request for a license change regarding License Number 47-25025-01. If you have any questions
