The purpose of this modification is to: (1) exercise option year one, in accordance with Federal Acquisition Regulation Clause 52.217-9, entitled, "Option to Extend the Term of the Contract." As a result of this action (2) the period of performance is extended through July 13, 2008 and (3) the contract ceiling amount is increased by \$841,115.92 from \$822,074.32 to \$1,663,190.24, and (4) FY'07 funds are obligated in the amount of \$500,000.00, thereby increasing the obligated amount of the subject contract from \$733,000.00 to \$1,233,000.00.

Accordingly, the following changes are hereby made:

1. Section A.1, "CONSIDERATION AND OBLIGATION," is deleted in its entirety and substituted with the following in lieu thereof:

"A.1 CONSIDERATION AND OBLIGATION

(a) The total estimated amount of this contract (ceiling) for the products/services ordered, delivered, and accepted under this contract is **\$1,663,190.24**.

(b) The amount presently obligated with respect to this contract is **\$1,233,000.00**. This obligated amount may be unilaterally increased from time to time by the Contracting Officer by written modification to this contract. The obligated amount shall, at no time, exceed the contract ceiling as specified in paragraph (a) above. When and if the amount(s) paid and payable to the Contractor hereunder shall equal the obligated amount, the Contractor shall not be obligated to continue performance of the work unless and until the Contracting Officer shall increase the amount obligated with respect to this contract. Any work undertaken by the Contractor in excess of the obligated amount specified above is done so at the Contractor's sole risk."

A summary of obligations for this contract from award date through the date of this action is given below:

Total FY'07 Obligation Amount	\$700,000.00

Cumulative Total of NRC Obligations: \$1,233,000.00

This modification obligates FY'07 funds in the amount of \$500,000.00.
