The purpose of this modification is to:

- (1) Provide the labor and travel to allow L-3/GSI to develop a comprehensive plan for the transition of the NRC's email system from Novell Groupwise to Microsoft Exchange/Outlook, as provided below.
 - revise the labor hour requirements of Schedule A-1 Year 6 (Current) of the task order to **add** the following positions: One (1) Sr. Consultant (Microsoft Consulting Services), One (1) Sr. Consultant Tools (Quest Software, Inc.), and One (1) Project Manager (Quest Software, Inc.);
(Refer to Page 3 of this modification for details)
 - revise CLIN 0010 Travel. (Refer to Page 3 of this modification for details)

This modification confirms the authorization provided to L-3 via email dated 9/13/2006, as revised 9/14/2006, to commence work under this effort with a temporary cost ceiling not-to-exceed \$100,000.00. Reference is made to L-3/GSI's proposal dated August 30, 2006, as revised December 14, 2006 and **April 2, 2007**, in response to this effort.

THIS EFFORT SHALL BE PERFORMED IN ACCORDANCE WITH THE ATTACHED STATEMENT OF WORK (ATTACHMENT #1).

As a result of the above,

- The total estimated amount (ceiling) for Year 6 (Current) of this task order is increased by **\$101,667.68**, from \$15,604,658.96 to **\$15,706,326.64**.
- The total estimated cost (ceiling) of this task order is increased by **\$101,667.68**, from \$70,722,829.30 to **\$70,824,496.98**.
- The total estimated value, inclusive of all options, of this task order is increased by **\$101,667.68**, from \$114,539,963.30 to **\$114,641,630.98**.

Accordingly, the task order is modified as follows:

1. Subsection B.8 CONSIDERATION AND OBLIGATION, the first sentence of paragraphs (a) is deleted entirely and the following is substituted in-lieu thereof:

"(a) The total estimated amount of this contract (ceiling) for the product/services ordered, delivered, and accepted under this contract is **\$70,824,496.98.....**"

2. **Schedule A-1 Year 6 (OPTION)** of the task order, **CLIN 0006C** is hereby revised to **add**, after all previous entries, the following positions: One (1) Sr. Consultant (Microsoft Consulting Services), One (1) Sr. Consultant Tools (Quest Software, Inc.), and One (1) Project Manager (Quest Software, Inc.), thereby increasing the Total CLIN 0006 amount by **\$89,667.68**, from \$12,183,075.00 to **\$12,272,742.68**, as follows:

STATEMENT OF WORK

(Task Order DR-01-0290, Modification No. 65, Attachment #1)

"Transition of Novell Groupwise to Microsoft Exchange/Outlook"

Background

The Chairman of the US Nuclear Regulatory Commission (NRC) directed on July 26, 2006 that the NRC begin planning to transition from the Novell GroupWise email system to Microsoft Exchange with the Outlook desktop client as the new agency standard. Successfully transitioning from the current email system to Microsoft Exchange/Outlook will require a tremendous amount of planning and coordination. In order to properly scope this project, a detailed project plan, project schedule, and a list of project resource requirements must be developed.

Objective

The Contractor shall develop a comprehensive plan for the transition of Novell Groupwise to Microsoft Exchange/Outlook. The transition plan is due to the NRC Project Officer no later than close of business Jun 12, 2007. The Contractor shall provide additional assistance (e.g. expert advice, plan modification) between September 13, 2006 and June 12, 2007, as requested by NRC.

Period of Performance

September 13, 2006 through June 12, 2007.

Requirements

1. The project plan shall cover all phases of the project, including but not limited to: discovery of the NRC GroupWise environment to be migrated, determining what components of the current NRC Novell infrastructure need to be migrated with the email system, developing the architecture of the new NRC Microsoft Exchange environment, planning and scheduling the migration, running and managing the actual migration of the email system and the related resources, and the decommissioning of the old GroupWise email system from the NRC production operations environment. If necessary, an outside contractor or consultant should be utilized to serve as a collaborator in finding the correct approach to address all the issues associated with an accelerated approach, including security of the NRC network.
2. The plan shall identify any non-L-3/GSI resources required, such as expertise from Microsoft and other vendors that may be leveraged to ensure that all Microsoft Exchange best practices are used in the design, implementation, and maintenance plans for the deployment of the system in the NRC environment.
3. In order to ensure a smooth transition to Microsoft Exchange for the agency, the planning shall take into account the other parts of the current NRC Novell infrastructure that may be adversely affected by the migration of the GroupWise email system. If other components of the existing NRC Novell infrastructure need to be migrated to Microsoft services to facilitate the migration to Exchange / Outlook, those requirements need to be documented in the task project plan, project schedule, and resource requirements where applicable.

4. The project plan and timeline shall note where schedules can be coordinated with other tasks (e.g. infrastructure refresh, server refresh, SAN refresh) that will have a direct effect on the progress and success of the GroupWise / Exchange migration task.
5. The plan shall identify research that must be done to identify all COTS products, NRC developed applications, and any other systems in the environment that rely on the current Novell GroupWise infrastructure. This will allow the appropriate system owners to be notified of the need to start the planning for the transition and integration of those systems to the new Microsoft Exchange / Outlook environment.

Deliverables and Delivery Schedule*

Deliverables shall be provided to the NRC Project Officer in both hardcopy and either electronic format or on CD.

1. Detailed Project/Implementation Plan
2. Detailed Project Schedule
3. Resource Requirements
4. Impact statement of resources needed for this project currently scheduled on other projects.
5. Inventory of all COTS, NRC developed applications, and other systems that have dependencies on the current Novell GroupWise email infrastructure that were identified during the research for the task.
