- 🌀 Base lining activities ~75% complete. One quarter of base lining to be completed.

# Current Company Status

## Drilling Program

- YTD 2007 – 95 exploration drill holes have been drilled.
- 94 drill holes have been reclaimed. This includes all 2006 drill holes and some 2007 drill holes.
- Approximately 180 holes will be drilled in 2007.
- Drilling Bond has been increased to \$50,000.

# Soils

- Soils Survey completed in December 2006.
- Survey approved by WDEQ-LQD prior to being conducted.
- Sampling focused on proposed plant locations.

# Vegetation

-  Vegetation Surveys conducted in June and July of 2006
-  Survey plan approved by WDEQ-LQD prior to conducting survey.

# Wildlife

- Wildlife field studies conducted April-June 2006, February 2007, and April-May 2007.
- Two years of background sage grouse data was collected.

# Wetlands

- ☞ Wetlands Survey conducted June and July 2006.
- ☞ Potential wetland areas were identified and delineated.




# Cultural Surveys

- ❧ Cultural Surveys have been conducted on both the Nichols Ranch and Hank permit areas during 2006 and 2007.
- ❧ A Paleoentological Survey was completed in May 2007 for both Nichols Ranch and Hank permit areas.

# Hydrology

- Groundwater base lining plan approved by WDEQ-LQD.
- Groundwater base lining currently being conducted with 3 quarters of data collected.
- Pump tests (multiply and single well) have been conducted on both Hank and Nichols Ranch.
- More hydrological testing will be conducted on Hank property with the installation of three new wells.

# Other Activities

-  Status Update Meeting held with the Wyoming DEQ in early June.
-  Meetings held with Coal Bed Methane Producers in permit areas.
-  Planning for monitor well installation and pump test.

# Nichols Ranch ISR Project Permit Submittal

- WDEQ-LQD Permit to Mine and NRC Source License Application are planned for submittal in November 2007.
- Applications will be submitted concurrently.
