Dear Sirs,

We wish to amend the above referenced license to add an additional field station. This facility is to be located at 160 Lavoy Road, Erie, Michigan 48133. This site is to be used for storage of radioactive materials, and for dispatch to other job sites.

The radioactive material and devices are to be stored in a lockable steel box, located inside a lockable storage building to be located inside the warehouse area. The warehouse area will be lockable, alarmed, and motion sensor equipped. The storage building will be lockable, alarmed, and also motion sensor equipped. Enhanced security procedures will be in place, with unescorted access to radioactive material limited to authorized personnel. The steel storage box is designed to accommodate a maximum of four (4) 100 curie IR-192 exposure devices. Radioactive Material signs will be posted on the steel storage box and the storage building. The shielding and distances involved would result in any possible exposure to unmonitored personnel to be far below regulation limits. The location of the storage building and planned activities in the warehouse should result in virtually no exposure to any unmonitored personnel.

An overall plot plan depicting the building in relation to the general area, and a plot plan of the building showing the storage building and storage box is enclosed. Also enclosed is a document from the landlord authorizing storage of radioactive material. The business in the other half of the building is an industrial coating company that performs specialty coating at offsite locations.

We are requesting this amendment be expedited due to economic reasons. If there are any questions or comments, please contact me.




