Dear Sir or Madam:

The purpose of this letter is to amend the current license for the main storage location at 318 Cruzar Road, Triadelphia, WV 26059. We have moved the main storage area from our previous location at 1191 Pittsburgh Road, Valencia, PA, 16059, to the West Virginia location above, in a letter dated March 27, 2006. Since then, our office at Triadelphia has been given a new address due to EMT requirements, and our main office has moved completely. Our physical address in West Virginia remains the same, but the number has changed from 318 Cruzar Road to 56 Cruzar Road. Our main office address has changed from 1191 Pittsburgh Road to 441 Mars Valencia Road, Suite 100.

We wish to change our licensee information on #2 of the front page of the materials license from "1191 Pittsburgh Road, Valencia, PA 16059" to "56 Cruzar Road, Triadelphia, WV, 26059", effectively changing our Pennsylvania license to a West Virginia license. As per a recent inspection by your offices, we wish to change #8A from "No single source to exceed the maximum activity specified in the certificate of registration issued by the U.S. Nuclear Regulatory Commission or an Agreement State" to read "9 millicuries per source and 18 millicuries total" Also, we wish to change #8B from "No single source to exceed the maximum activity specified in the certificate of registration issued by the U.S. Nuclear Regulatory Commission or an Agreement State" to read "44 millicuries per source and 88 millicuries total".

We wish to change Conditions. #10, from "...1191 Pittsburgh Road.." to our new address, "...441 Mars Valencia Road, Suite 100...", and from "...318 Cruzar Road..." to "...56 Cruzar Road...", reflecting the changes in both addresses.

Lastly, please change the "tie-down" document list under #21 to add this letter.

We should not need Form 313 or Appendix B, as these changes represent no movement nor require transportation of any materials, just re-designation of addresses.
