

Merit Mountainside, LLC, a wholly owned subsidiary of Merit Health Systems, LLC and AHS Hospital Corp. have entered into an asset purchase agreement for the purchase of substantially all of the assets of Mountainside Hospital by Merit Mountainside, LLC from AHS Hospital Corp. AHS Hospital Corp. owns a licensed and operational general acute care hospital, a School of Nursing, and certain other real property, including residential properties and vacant land, all located in and around the Towns of Glen Ridge and Montclair, New Jersey. The expected closing date for this transaction is May 31, 2007. The name of the hospital will remain Mountainside Hospital.
