Dear Chairman Klein:

Over the past week, two separate issues regarding the NRC have come to light that we feel are cause for concern. First, the Government Accountability Office (GAO) reported to Congress on its ability to set up a false company, and within a month, obtain a license to buy radioactive material. Second, inadequate safety procedures and controls at the Nuclear Fuel Services (NFS) plant in Erwin, Tennessee, led to an alarming release of highly-enriched uranium in March 2006.

The safety and security of our nation's nuclear infrastructure and radioactive devices is the NRC's most basic duty. In our leadership capacity on the Senate Clean Air and Nuclear Safety Subcommittee, we have always sought to ensure that the NRC is capable of fulfilling this responsibility. It is extremely disturbing that NRC's licensing process was so easily circumvented by the GAO and that a facility that involves highly-enriched uranium solution could be licensed with what appears to be very minimal configuration and procedural controls. These two incidents raise serious questions about the capacity of the NRC to carry out its most important function.

Additionally, we have worked hard over the past several years to prompt your Agency to be more open and proactive in its communications with outside stakeholders. Time and time again, we have stressed the importance of improving public confidence in the Agency with you and your predecessors, especially in light of the fact that this country is facing a resurgence of nuclear power, a resurgence that we welcome. That is why we are disappointed that these two serious incidents were not shared with us in a timely fashion.

Regarding the undercover operation conducted by the GAO, it is our expectation that when such an alarming report is being presented to Congress, the Commission will schedule a personal briefing with us the day the report is being presented, or as close to that date as possible. With respect to the incident at the NFS facility in Tennessee, we are concerned with the Commission's failure to notify Congress and the public in a timely manner.

While the NRC has given us reasonable assurance that these two safety concerns will be resolved in the near future, we request a full report be prepared for our offices by the beginning of September. Specifically, each report should include at least the following information:

1. A synopsis of the incident itself;
2. A complete listing of institutional and episodic failures of the Commission and/or of the licensee;
3. A full report on corrective actions the NRC has identified and a timeline for their implementation; and,
4. A list of suggested corrective actions that the NRC does not have the statutory authority or resources to implement in a timely fashion.


We will be closely monitoring the Agency's response to these incidences and will expect a progress report at our next oversight hearing that is likely to be held in the September-October time frame.
