Dear Dr. Klein,

This Committee has worked to ensure that the NRC will be able to meet the challenges of the expected new reactor applications. During the licensing process for the current generation of nuclear power plants, there were several examples of completed plants that waited years to be granted operating licenses. I am aware that NRC has changed its licensing regulations to streamline the process into the current Combined Construction and Operating License (COL). I look forward to actual application of this new process.

Some of the delay in licensing plants in the past has been attributed to hearings that were conducted prior to issuing the license. I understand that you asked Commissioner Merrifield to lead a task force to study NRC's reactor licensing review process for recommendations on enhancing effectiveness and efficiency. The Committee is very interested in understanding what the NRC has learned, and whether the NRC would recommend changes in its hearing process to make it more efficient without negatively impacting its effectiveness.
